ELIGIBILITY: All contestants must provide a valid USA JUDO, USJA, USJF or ATJA card. Foreign contestants must have the proper ID from their home country. (Membership registration will also be available at the site.) The Tournament Director reserves the right to make necessary adjustments for the successful operation of the event. The Tournament Director may refuse any entry that is found to contain false information.

SCORING: True Double Elimination

MATCH TIMES: All Junior, Masters, and Novice Senior Matches will be 3 Minutes
All Advanced Senior Matches will be 4 Minutes

MATS: 3 Mat Areas will be used

RULES: The current rules of the International Judo Federation (IJF) as modified.

1. GOLDEN SCORE will apply to ALL DIVISIONS.
2. NO Kansetsu waza allowed in Junior Division
3. Shime waza allowed for 13 yrs. of age and up
4. Kansetsu waza allowed in all Advanced Senior Divisions regardless of age. (min. age for Sr. div. is 15) **No Kansetsu waza in novice senior divisions**

5. Juniors will be allowed to be examined by medical without forfeiting the match
6. If you wear a blue gi, you must also have a white gi
7. Must be in judo gi to receive your medal
8. Must Have your Own White & Blue Belts
9. Must have Footwear on when you are off the Mat

Medals for first, second and third place winners
 Team Trophies – 1st (34"), 2nd (32") and 3rd (30") – [Team points are given as follows:
 1st Place = 10 points; 2nd Place = 7 points; 3rd Place = 4 points; each entry = 1 point]

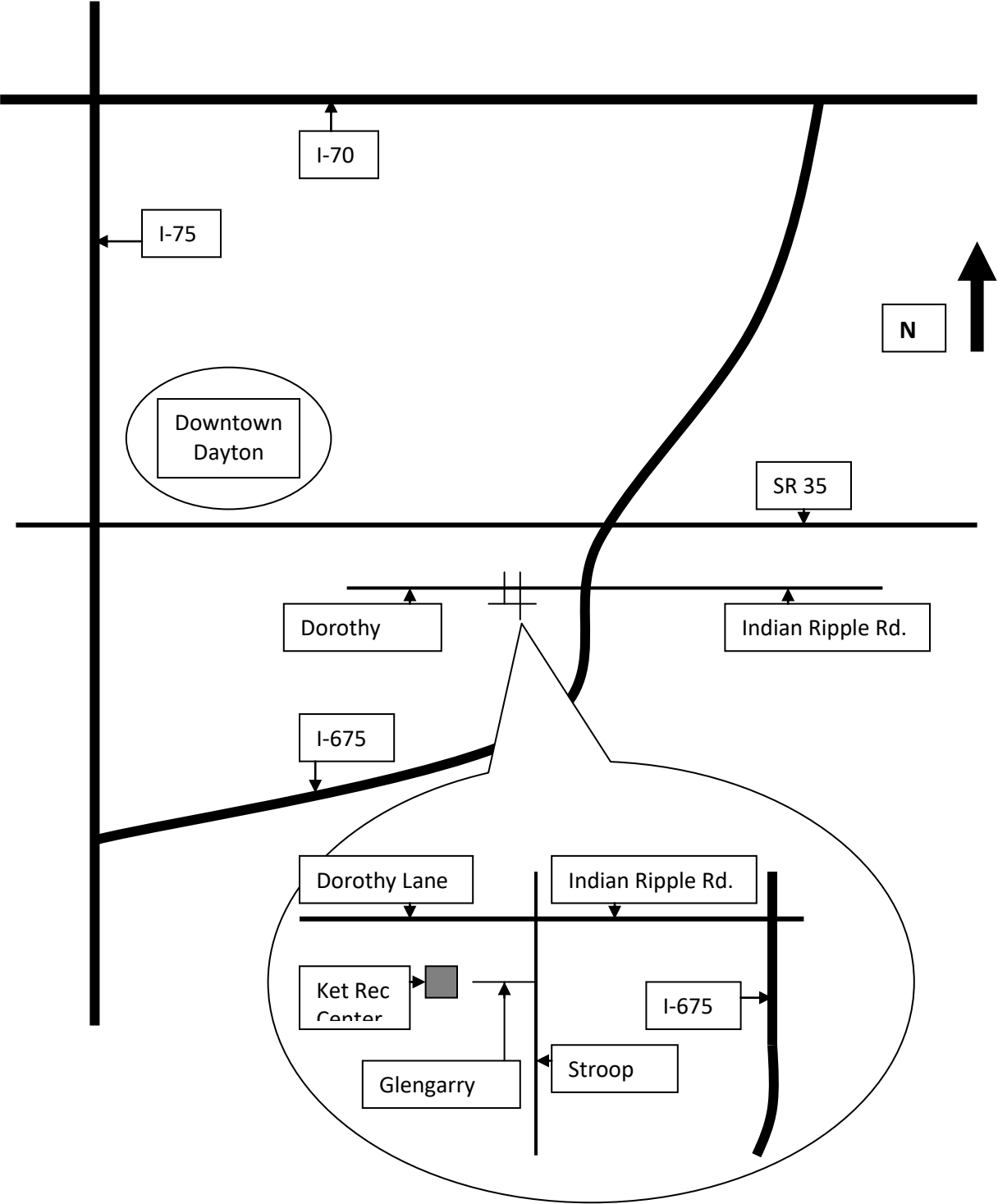

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, the 2018 Kettering Judo Classic and related events and activities of **USA Judo, USJA, USJF, ATJA, Ohio Judo, Inc., Kettering Recreation Center, and the KRC Judo Club**, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.

2. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such condition(s) and refuse to participate.

3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, Traumatic Brain Injury (TBI), and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the action, inaction or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability or death.

5. Release, waive and discharge and covenant not to sue the **USA Judo, USJA, USJF, ATJA, Ohio Judo, Inc., Kettering Recreation Center**, and the **KRC Judo Club**, together with their affiliated clubs, their respective administrators, directors, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardian(s), supervisors and coaches, sponsoring agencies, sponsors, advertisers, and, if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereafter referred to as "releasee", from any and all claims, demands, losses, or damages on account of injury, including permanent disability or death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise to the fullest extent permitted by law.
