After call to order of officers, the minutes from the April 26, 2008 meeting were approved as amended by the board (motion by Lorey Edwards, second by Russ Scherer).

The meeting continued with reports by the officers beginning with the Treasurer, Michael Mooney.

TREASURER and REGISTRATION

The Treasurer provided information regarding the state of financials currently in the OJI's account by distributing copies of the banking summary, check register and income/expense report. Michael Mooney and the board moved OJI's funds to Mr. Mooney's company savings account in order to generate interest rate of 2 & 7/8%. In addition, the funds are now immediately accessible without a waiting period.

Michael Mooney also informed the board of the current number of registered clubs is (9) nine and the number of individual memberships is (195) one hundred ninety-five.

There was discussion of coach certification and background check requirements. The state will hold all club registration certifications until it has been able to verify these requirements have been met through the national approval

OPERATIONS and BUDGET COMMITTEE

Jim Starcher, Director of Operations and Chairman of the Budget Committee, stated there were no budget requests turned in. Mr. Starcher directed the group and lead the discussion to create an operating budget for 2009. The budget for 2008 was used as a guide with specific modifications to accommodate OJI's needs for 2009.

DEVELOPMENT

Janice Scherer presented to the board the participation results for team travel and regional tournament reimbursement participation. The athlete names participating in each event are available through Russ Scherer.

The team travel trip planned for Washington DC was cancelled.

STANDARDS & CERTIFICATION

Russ Scherer discussed getting new people referee certified and getting current certified referees upgraded to their next level. Russ is planning on hosting a rules clinic which will be open to players, coaches and officials. The new rules set is expected by January from the IJF.

Mr. Scherer also has a few dates in mind to hold Rules Clinic, Beginner Local Level Tournaments, Timer & Scorer Clinics and Super Saturdays. He asked for suggestions on how to encourage participation to ensure these events are well attended and successful.

Russ Scherer had contact with the Cincinnati Activities Winter Sports Festival representatives. Russ asked if OJI had any interest pursing this participation venture. This year's date is scheduled for December 13 & 14, 2008. Russ suggested attending to see how the event operates to determine if OJI would be interested in working toward the 2009 event.

LAW & LEGISLATION

Tom Jones has resigned from the board due to work conflict. Mark Hunter, OJI President, is looking for candidates willing and able to fill this position.

All other officers had no items to report.

WEB COMMITTEE

OJI is looking for volunteer to take charge of this task.

COACHING

Andy Bosiljevac stated he was receiving little to no interest in state team participation. Once a team travel event scheduled, OJI will require coaches, a manager and chaperone's to assist with the team

PROMOTION COMMITTEE

Frank Herzog presented to the board a list of promotions current through April 2008. He asked if the current promotional system is fully functional and servicing the clubs and individuals properly. No one had any complaints or suggestions for improvements.
