The Kitty Hawk Judo Club is going to hold a team and club invitational. State team against state team and club against club.

At the same time we have the State Junior Olympics we will have the Senior Invitational. The Senior invitational is to help raise money for the state senior team. The money from the State Junior Olympics goes to those who place at the National Junior Olympics, and they have to take first place at State Junior Olympics. The Junior team will be picked at the State Junior Olympics. To be able to participate on the state junior team you have to be a member of USJI.

This year there is a novice divisions in the High School Nationals. Too be eligible for the money from the State High School Championships you have participate in the elite divisions, and place in the state high school championship.

For the senior to get any money for going to the Senior Nationals you have to place first and come to the senior workouts, and belong to USJI.

The profit from the state tournaments have to be given to Bobby Anderson before it can be distributed to the competitors.

The Junior State workouts will be once a month after the state junior olympics.

The Junior State Championships will not be held this year.

Les Fazekas doesn't know if he will be holding the Shodokan camp this year it will depend on whether he can get the camp for a week. He will also check to see if he can get the camp for a weekend for a techer certification camp, if not Russ Scherer might hold one, watch for further information on these.

Ohio State Jundo Inc. would like to hold an awards banquet this year at the end of the year for outstanding players, and to recognize other people for such a good job they have done.

Bobby Anderson and the Executive Committee would like to start an OSJI Hall of Fame. If any body has any information or pictures of judokas or coaches from the past years please send the information to Bobby Anderson. If you have any addresses of any pass judokas or coaches also send them to Bobby Anderson.

Executive Committee made an announcement that we have to appoint a new Standard and Certification Chairman. Bill Doyle nominated Les Fazekas. Les Fazekas said he would like to think about it first. So at the next executive Committee meeting we will be nominating someone to that position.

Bobby Anderson handed out his expense and income report which is included in these minutes.

Russ Scherer brought up the idea of having Pittsburg buy the mats that OSJI loan the money to Prof. Ryozo Nakamura for the mats be bought for National Junior Olympics. If Pittsburg doesn't want them then OSJI to keep the mats.

Bill Doyle appointed Bobby Anderson for head coach for the State Junior Team, and Paul Jordan the assistant Northern Ohio coach and Bob Spraley the assistant Southern Ohio coach. Frank Herzog the head coach for seniors.

Russ Scherer gave a bid to the National board to hold the 1993 National Ladder, but we don't know yet if we got it.

Bill Doyle adjourned the meeting.
