C. Reports of Officers

President -

1) The "Midwest Presidents Group" has been established including Wisconsin, Illinois, Indiana, Michigan, Ohio and Kentucky. The goals of the group include coordination of tournament schedules, mutual support for our activities, joint projects, etc. Several Zoom meetings have resulted in the following actions: a) event scheduling will be tracked on the OJI website and prioritized with state championships on top, large sub-national (e.g. Cohen Memorial, Komatsu Cup, etc.) next, then smaller regional and local events; b) State Team competition will be added at the end of the regular divisions at each of the state championships – each state will be allowed to enter 1 team – and points will be tracked throughout the year with awards at the end of the year – the program will tested with Senior teams; c) Referee Program development: two Zoom clinics have been held (8/8 and 8/29) for potential and current referees, covering an overview of the Referee Training Index located on the OJI website – additional training sessions are scheduled for !0/4 (Why referee? by Alex Murray) and on 10/25 (miscellaneous referee information – the final part of the Training Index by Russ Scherer)

- E. Reports of Athlete Reps It was requested that OJI see if there is anything that we can do to help those clubs that may not be able to reopen due to the financial (or other) effects of the Covid-19 Pandemic.

G. Unfinished Business

Report on 2020 Ohio Open Championships – We had 144 entries, good competition, OJI profit of \$1,464.34 and got it all in prior toCovid-19 closing everything down – overall a very successful event.

Report on 2020 Awards Banquet – Our first ever Hall of Fame Banquet honored Kayla Harrison and Ryozo Nakamura. The turnout was much less than expected, leading to a shortfall of approximately \$1,000 but those that did attend all seemed to have a great time and were very happy that this recognition program has been established.

Status of Tri-State (OH, IN & KY) Team Shiai Program – This program has been expanded into the Midwest program discussed in the President's report above.

H. New Business

Zoom meetings implementation – Due to Covid-19 restrictions we were forced to hold our Fall meeting on Zoom, which had actually been discussed prior to any signs of the pandemic. We used the free version of the software which met our needs for this meeting, primarily because a special was being run that allowed a much longer meeting time (the free version is normally only 40 minutes max. We discussed the options of purchasing Zoom Pro versus using a different free platform – research will continue.

Selection of 2021 Inductees for Ohio Judo Hall of Fame – Potential candidates were discussed, reviewing their contributions, and Les Fazekas and Russ Scherer were selected. We hope to be able to have a banquet similar to 2020, the evening prior to the 2021 Ohio Open State Championships – possibly in late Spring. We will be looking at additional fundraising to offset some of the expenses so we do not have a shortfall again next year.

Awarding the 2021 Ohio Judo Championships & Hall of Fame Banquet – It was decided to hold off awarding these events until the beginning of November due to the uncertainties caused by the everchanging Corona virus impact. Proposed Programs for 2021 – The scope and timing of 2021 programs will depend on the restrictions in place due to Covid-19 as the year progresses. We anticipate there will be activity in the following areas (at a minimum):

Bylaws Amendment – MOTION: "Delete the second sentence of Article III, Section 10" – This section would then read "SECTION 10. The officers shall take office on January 1 following the fall meeting at which elected and shall serve for a term of two (2) years." RATIONAL: Dropping the prohibition of electing an officer to more than two consecutive terms will allow the members to fill each position with the person they desire without overriding the Bylaws, which has happened several times in the past. Since this motion had already been passed unanimously at the March 3, 2013 OJI Board of Directors Meeting, this motion was modified to "Validate the desire to remove the limitation of only allowing two consecutive terms in the same position and update the Bylaws to reflect this change". MOTION PASSED UNANIMOUSLY

Bylaws Amendment – Administrative – update the bylaws to reflect the increase in Club Membership dues in OJI to \$50/year which passed unanimously on 12/15/19, effective 1/1/2020. MOTION PASSED UNANIMOUSLY
