- ELIGIBILITY:** All contestants must provide a valid U.S.J.F., U.S.J.I., or U.S.J.A. card.  
Foreign contestants must have the proper ID from their home country.
- NOTE:** Membership registration available at the site.
- SCORING:** Software Decides pooling! Round Robin (3 or less in a division)
- MATCH TIMES:** Sr. Men & Women Black & Brown Division 4 min. all other Divisions 3 min.
- COACHES:** Must wear appropriate dress: national or club team track suit (sweat suit) with polo shirt; business casual attire, dress jeans, button down shirts or polo shirts. Dress shoes, tennis shoes.
- RULES:** The current rules of the International Judo Federation (IJF) as modified.

1. Junior Division – 8 through 16 years of age
  - a. Juvenile A (age 13 through 16) No Kansetsu Waza allowed - Shime Waza allowed
  - b. Juvenile B (8 through 12) No Kansetsu Waza allowed, No Shime Waza allowed
2. Kansetsu Waza allowed in all Senior Divisions, except Novice Division (minimum age for senior division is 13).
3. Current IJF Medical Rules – All Divisions
4. Must be in Judo Gi to receive your Trophy
5. Blue & White belts required.
6. The contest area will be 10x10 with 4-meter safety zone and out of bounds area between adjoining contest area and 3 meters everywhere else.

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.

2. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such condition(s) and refuse to participate.

3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, Traumatic Brain Injury (TBI), and severe social and economic losses due not only my own actions, inactions or negligence, but also to the action, inaction or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability or death.
